#### **Seminar on Child and Women Atrocities**

Department of Law organized a seminar on "Child and Women Atrocities" on 2nd April 2022. Keynote speaker of the event was Mr. OP Muwal, Dy. Director – Women and Child Dept. Jodhpur. Muwal ji explained the practical aspects of women atrocities and he informed that Violence against women in India refers to physical or sexual violence committed against a woman, typically by a man. Common forms of violence against women in India include acts such as domestic abuse, sexual assault, and murder. In order to be considered violence against women, the act must be committed solely because the victim is female. Most typically, these acts are committed by men as a result of the longstanding gender inequalities present in the country. It is actually more prominent than it may appear prime facie, as many expressions of violence are not considered crimes, or may



otherwise go unreported or undocumented due to patriarchal society, values and beliefs. These reasons cumulatively contribute to India's Gender Inequality Index rating of 0.524 in 2021, to putting it in the bottom 20% of ranked countries for that year.

Faculty members Nitish Dadhich and Kriti Sanadhya compared the event while Dr. Sanjaya Chaudhary and Brijesh Kanwar highlighted the legal aspect of the topic.
